II. Feedback to policy event - MSCA contribution to bridging research & innovation and standardisation for EU competitiveness

In an increasingly complex and interconnected global environment, standardisation plays a pivotal role in translating research outputs into impactful and scalable innovations. Recognising this, the European Commission has identified the need to reinforce the links between research, innovation, and standardisation to boost the EU's technological sovereignty and industrial competitiveness.

The Marie Skłodowska-Curie Actions (MSCA), as part of Horizon Europe, are uniquely positioned to act as a bridge between academic research and industrial and societal needs. With their focus on excellence in doctoral and postdoctoral training, intersectoral mobility, and stakeholder engagement, MSCA-funded projects can become key vehicles in embedding standardisation into the research and innovation lifecycle.

Given the instrumental role that MSCA can play, this event aims to identify practical steps to better and more systematically integrate standardisation into relevant MSCA projects, by presenting relevant policies, successful cases, stakeholder perspectives, and existing tools, networks and matchmaking platforms.

III. Frontiers Planet Prize: webinar on how to get involved and nominate for the next edition

The International Science Council is proud to partner with the Frontiers Planet Prize in recognizing and rewarding exceptional scientists working in sustainability science.

Frontiers Research Foundation has launched the Planet Prize to recognize and reward exceptional scientists. Three prizes worth a total of CHF 3 million (~USD \$3.2m) are awarded each edition to the world's most innovative sustainability scientists who are able to offer globally scalable solutions which protect and restore planetary health. All domains of science are considered.

Organisers invite interested parties and their networks to join their information session providing more information on the overall mission and objectives of the Planet Prize, the eligibility criteria for scientists, the mechanics of the Prize and the role of the ISC in engaging its Members around this scientific competition.

IV. Into Change Award

The Into Change Award honours outstanding European research groups whose work drives scientific breakthroughs, benefits society, and reflects core values like curiosity, collaboration, and openness.

The prize consists of DKK 8 million (Danish kroner) and is given by the Danish Ministry of Higher Education and Science. Novo Nordisk Foundation, Carlsberg Foundation and Villum Foundation, part of the VELUX foundations, has contributed DKK 1 million each to the total amount in 2025.

The Into Change Award is awarded to a group of researchers from institutions in Europe, who have demonstrated outstanding, ground-breaking research with substantial or fundamental societal significance and/or impact, and who have demonstrated the values of curiosity, collaboration, responsibility, respect, and openness in research at an exceptional level. The prize can be awarded to research groups within and across all fields of science and to both current/active and former research groups.

Nominations must be submitted via the online system e-grant (<http://www.e-grant.dk>). Submission opens **1 June, 2025** and closes on **1 August, 2025** at 12 (noon). Each institution is encouraged to nominate no more than one research group in total. It is not a requirement that the nominated group(s) are affiliated with the nominating institution/company.

V. ERC Advanced Grants

ERC Advanced Grants are designed to support excellent Principal Investigators at the career stage at which they are already established research leaders with a recognised track record of research achievements. Principal Investigators must demonstrate the ground-breaking nature, ambition and feasibility of their research proposal.

Advanced Grants may be awarded up to a maximum of EUR 2 500 000 for a period of 5 years (the maximum amount of the grants is reduced pro rata temporis for projects of a shorter duration).

However, up to an additional EUR 1 000 000 can be requested in the proposal to cover (a) eligible "start-up" costs for Principal Investigators moving to the EU or an Associated Country from elsewhere as a consequence of receiving the ERC grant, and/or (b) the purchase of major equipment, and/or (c) access to large facilities, and/or (d) other major experimental and field work costs. As any additional funding is to cover major one-off costs it is not subject to pro-rata temporis reduction for projects of shorter duration. All funding requested is assessed during evaluation.
